**ORDER**

AND NOW, this 7<sup>th</sup> day of August, 2017, upon consideration of Plaintiff's (Grand Gedeh Association in the Americas, Inc.'s) Petition for Preliminary Injunction pursuant to P.R.C.P. § 1531, the response of Defendants, Fred Gwyan, Jeremiah Shar, and after a hearing held on said Petition on August 4, 2017, the Court finds that Plaintiff has set forth sufficient facts to establish its right to relief, that Plaintiff is likely to prevail on the merits of the case, and that greater injury will occur from refusing to grant the injunction being sought by Plaintiff than from granting the same.

It is **ORDERED** and **DECREED** that

- a. Gwyan and Shar are enjoined and barred from representing their status as Grand Gedeh Association in the Americas, Inc. (GGAA) officers, and from using the name of GGAA with respect to representations or solicitations, directly or indirectly, on behalf of or for the benefit of GGAA.
- b. a constructive trust shall be imposed on all funds solicited or collected by Gwyan or Shar purportedly on behalf of and for the benefit of GGAA since May, 2015,

where Gwyan or Shar have failed to provide to GGAA an accounting of the funds solicited or collected.

- c. Gwyan and Shar are enjoined and barred from dissipating, transferring, secreting, or otherwise wasting any funds or property that they hold as constructive trustees on behalf of GGAA.
- d. Gwyan and Shar shall inform the individuals and entities who had been misinformed of their status as GGAA officials - through the same methods and manner that said individuals and entities had originally been misinformed - that they (Gwyan and Shar) are not officials of GGAA and do not have the authority to function as, act in the capacity of or represent GGAA.
- e. ~~Gwyan and Shar are enjoined and barred from continuing to manage, operate or control the GGAA website or any other GGAA social media platform, such as Facebook, used to disseminate information to GGAA members, and shall provide to the current GGAA National President, Augustine Manyeah, all access information, codes, logins, passwords, etc. of the GGAA website and any other GGAA social media platform.~~
- f. Gwyan and Shar (i) turnover all GGAA Assets/properties and documents that are in their possession and control to the GGAA's National Board of Directors, (ii) desist from representing their status as GGAA officers, and (iii) desist using the name of GGAA with respect to representations or solicitations, directly or indirectly, on behalf of or for the benefit of GGAA.
- g. ~~award plaintiff reasonable attorney fees and costs, upon presentation of verified schedule of services, accompanied by an attorney verification.~~

*This injunction shall be effective upon the posting of a \$2,500 bond.*
